### **MACHOL FARM**

Further to my letter dated 28 March 2008 sent via Registered A.D. post and Courier, I had asked you to contact me immediately. By immediately I meant, IMMEDIATELY.... You must have received this letter by courier on 29<sup>th</sup> March and should have contacted me by 31<sup>st</sup> March, which was yesterday.

I must remind you once again to contact me within 3 days or latest by Friday the 4<sup>th</sup> of April 2008 to avoid any legal or law enforcement action I may take against you and to regain possession of my land. In such case, you will be entirely responsible for everything. You must contact me to sort out this mess you have created.

Since last 6 years, I have been very patient with you on all accounts. I have phoned you several hundred times but you have not once contacted me. Apart from my phone calls, I have sent you letters, messages and I even hired an advocate who sent you legal notices and also this matter was published in Daily Kawish newspaper.

I have been very patient with you but my patience has now run out. You and Barzeen Pajnigara have both maligned my name, thrown false accusations at me, harassed and blackmailed me, taken undue advantage of your strong political position, forcibly moved my licensed shotgun, forcibly kept possession of my land, have refused to pay me my rightful share of the profits of Machol Dundh for the last 6 years and worst of all, have made me plead to you several times to pay me my share as I was in desperate need. *It is shameful that you have taken money (around Rs. 200,000) even from our poor Manager Master Ahmed Mallah and have not paid wages to chowkidars for the last 6 months. You forcibly purchased my land on installments and then reneged on the deal by not paying the installments. You have insulted, belittled, and humiliated me to extreme. You have cheated, reneged, lied and deceived. You have tried your best to destroy me. But Allah Almighty has saved me from your evil designs and intentions. Everyone will pay for their sins in this world and hereafter including yourself. May Allah forgive and bless us all and may Allah put some sense in you.

This is your last chance to redeem yourself. Please contact me on or before 4-4-08.
